I. Formal Apologies

Were received from M.Scott (Secretary), A.Hemingway (Finance), C.Ball, P.Johnson.

2. Minutes of Previous Meeting

Accepted as a true record.

3. Matters Arising

M.Gretton followed up introductory email with new Hull City OSC Chairman. Currently unable to agree a meeting date.

4. Supporters' Trust

Tigers co-operative voted by a clear majority to merge with CTWD. Tigers co-op committee re-elected until the merger takes place.

Proposed that CTWD merge with Tigers co-op and take on the current constitution. CTWD members are sent a copy of the constitution ahead of a new vote on the committee of the new supporters' trust.

M.Gretton to formally invite Tigers co-op committee to the October CTWD meeting to ratify the decision and agree a joint statement for members.

A.Mills to roughly document the next steps and timescales ready for discussion in October.





5. Campaigns

Asset of community value application (ACV) drafted by A.Mills agreed. Need to agree a physical address for CTWD in order to complete the application. Agreed to organise a PO Box for a year initially. A.Mills to follow-up acquisition of a digital map of the stadium.

Discussed recent developments from the club on the name change. Until the details of any arbitration are revealed there is no reason for CTWD to get involved.
