I. Apologies

2. Minutes of Previous Meeting

3. Matters Arising

M.Gretton has received no further communication from the new Hull City OSC Chairman.

4. Supporters' Trust

M.Gretton offered thanks to A.Mills for producing an action plan of the merger.

M.Scott explained the process and the points requiring discussion:

- Merge process
- Membership fees
- Aims & Objectives
- Name

Andy Mills spoke on the timeline and said the most difficult question was the timing of the first AGM for the merged trust. Jacqui Forster had also suggested that the action on bank accounts be brought forward as this would be a long process.

Invite members and interested parties to suggest names for the supporters trust and the best three or four suggestions will be put to a vote of the CTWD members.





M.Gretton proposed membership of £5 - £1 for the share of the trust and £4 member contribution. Discounts for children/elderly/disabled or families to be discussed. All agreed with the basic £5 fee. Agreed on 1st January as the start of the financial year and pencilled in January 31st (Newcastle home) for the AGM. R.Saunders suggested a 15 month initial membership to ease the load in future years.

Discussed comments and aims suggested by interested parties on message boards and social media in relation to CTWD's proposed "Aims and objectives" document.

R.Harmer suggested that collating information where fans are still concerned about their seat following the North Stand rearrangement could be something to do in the short term while the trust merger is going on in the background. C.Cooper and I.Waterson will lead on retrieving feedback on this and the atmosphere in the stadium.
