7. Living Wage

Everton are the latest football club to pay their employees the living wage. HCST to write formally to the club via J.Mooney. A.Mills to draft the letter.

8. FSF Away Tickets Campaign

HCST have added our support to the proposal being put to the Premier League to assist maximum £20 away tickets.

9. FWG Meeting

R.Harmer updated the board on the latest FWG meeting (full report will be added to the HCST website). Positive aspects have come out of the meetings regarding the Safety Advisory Group (SAG) and promised positive progress on disabled ticket pricing. C.Smith suggested asking the Premier League if and what guidance has been given regarding the ASI (Away Supporters Initiative) money the club have apparently failed to spend.

10. Safety Advisory Group (SAG) Meeting

R.Harmer updated the board on the SAG meeting (full minutes have been added to the HCST website). R.Harmer found the meeting interesting and was pleased that questions asked were answered in full.

11. Anlaby Road Ground Project

C.Smith has researched the design process. Suggested a brief would be the first step followed by putting it out to tender. Receive drawings at that point and then interview preferred candidates. C.Smith to research who owns the land.

Produce a page on the website for O.Harsley to write a summary of the campaign and to give interested parties a focal point of contact.

13. Chairman Update

M.Gretton has made numerous media appearances since the press release went out. The Hull Daily Mail has a piece on the trust forthcoming which M.Gretton will be meeting them about. The Chair shared correspondence with J.Forster about the Dementia Friends SD initiative which is ongoing. M.Gretton has had discussions with female members about getting more involved in setting HCST's agenda. So far unfruitful.
