I. Presentation from Middle Child Theatre Company

Director Paul and Producer Mungo spoke about the project with a working title "City Till We Die" about the passion of Hull City fans and importance of the club to the fans and community. The project has funding for research and filming interviews over a two week period scheduled for November. The show is expected to go live in May 2016.

Middle Child asked HCST to help with suggestion of venues to take the show. They have a home base on the Thornton Estate. Suggestions were made of New Walton Club, The Lair, Craven Park, Sailmakers Arms and the Freedom Centre.

HCST will be asked for input on ticket prices, venues, show times and any possible enticements such as food and drink.

M.Scott was keen that it looks forward rather than just raking over the issues of the last two years.

HCST will send an official letter of support for the project before the application goes in within 4/5 weeks.

C.Smith wondered if HCST could sponsor the event. The board agreed to wait for the direction before making any decision.
